ISP- MDS Dissertation Grants

Theme - Dental implants

The call for proposal is aimed to support individual MDS Students who are pursuing their post graduation in India in the specialty of Periodontology and intend to work on 'Oral implant related research work' during their MDS course. The scheme proposes to support 75 scholarships in total. The quantum of support shall be based on the scientific merit of the proposal. The amount of support to the MDS scholar shall range from providing /covering the cost of hardware to funding the entire cost of the study.

A. Eligibility:

The applicant must be a registered MDS Student and should apply within the first year of registering as MDS student. The MDS Student, and the PG Guide, must be the Associate and Life Member, respectively of the Indian Society of Periodontology.

B. Application Procedure:

The application should consist of Title of the project, detailed Synopsis under the subheadings of Background, Aims and Objectives, Literature review, Materials and Methods, Sample size calculations, Observation intervals, Duration of the project, Statistical methods to be applied, Scientific Implications, Timeline in the project, Novelty of the project, detailed expenses involved and how they are likely to be mitigated by the applicant. The proposal should be submitted in the prescribed format, as attached.

Deadline for Application: March 31st, each year. (Grants are reviewed annually and limited to one grant/institute/year)

Declaration of results: within one month after the submission of proposal.

C. General guidelines

- 1) The projects may be based on various aspects of oral implants such as basics of implant surgery, osseointegration, bone augmentation techniques like guided bone regeneration, various implant treatment protocols including placement and loading, maintenance protocols, material innovations, implant surface modifications, digital planning and surgical modifications, aesthetic outcomes with implant supported prosthesis and patient centered outcomes etc. or any other related research question.
- 2) The project submitted must be approved by the Institutional Ethical Committee and in case of a clinical trial; it should be registered with the Clinical trials registry of India (prior to the dispersal of grant).
- 3) The applicant must obtain a training for the Basic Research Methodology (minimal of 3 days duration) conducted by any recognized and accredited health University within six months, after the grant of scholarship.
- 4) Request for change in proposal, once submitted, will not be permitted and shall be summarily rejected. Proposals submitted to ISP need to be original and plagiarism more than 15% will not be acceptable.
- 5) Providing any false information during the course of application will be viewed adversely and may lead to disqualification of the applicant and his/her parent institute from future ISP grants.
- 6) The MDS student, and the his/her dissertation guide shall be responsible for timely submission of interim reports and completion of the project, failing which it shall be their joint responsibility to return the entire grant back to the society. The ISP head office will be entitled to take necessary legal action against both of them, in case of violation of the contract.
- 7) The application should be submitted by e-mail and also in triplicate by Speed Post to the ISP

- Head Office before the last date of submission.

- 8) On receipt of the applications, they will be evaluated by the "Scientific Research Committee (SRC) of ISP". The SRC,s decision will be final and binding & no correspondence shall be entertained under any circumstances, on the decision of SRC.

D. After the award of grant

- 1) Once a grant is awarded, the MDS student and his/her PG guide shall sign a contract/agreement with ISP, which would be the guiding document & sacrosanct.
- 2) The awardees will have to submit a copy of their University approved dissertation synopsis at the time of agreement with ISP and periodic "Progress Report" of their research work every six months from the date of the release of the grant by the ISP Head Office.
- 3) On approval, the grants will be released in three installments. The first installment of 40% amount will be released once the applicant submits acceptance letter. The second installment of 35% shall be released after the completion of the project. The completion report shall be evaluated by SRC and only on their approval; the second installment of the grant shall be released. The completion report has to be submitted along with a certificate from the PG guide. The rest 25% amount shall be released on publication of the paper based on the project findings in a renowned journal (Preferably in Journal of Indian society of Periodontology (JISP), or any quality indexed journal with higher impact factor). Any Article Processing Charges for the same will have to be borne by the applicant and will not be reimbursed by the ISP Head Office. Any unspent funds at the end of study, shall be returned to the society at the end of study.
- 4) An acknowledgement of the ISP grant has to be mentioned in the 'MDS Dissertation, Publication and Presentations' as follows:

- 5) The project shall be presented at least once as a poster at ISP national conference and as an oral paper at the annual ISP PG Convention during their MDS course, as a mandate for the grant recipients.
- 6) If the project is not completed up to the satisfaction of the Scientific Research Committee, no further projects shall be sanctioned to the parent institution of the MDS scholar, for next five years.

- 4) Undertaking by the applicant and PG guide that the same proposal is not receiving / has not been submitted to any other agency for financial support.(Annexure 3)
