## Election Notice

Notice is hereby given as per the constitution of the ISP to inviting nominations for the post of

4.	Joint Secretary	for the year 2017-18	1 Post

6.	Periodontal Health Care Convener	for the year 2017-18	1 Post
7.	Executive Committee Member (EC Member)	for the year 2017-18	35 Posts 1. Past President Category - 5 Posts 2. Existing EC Member Category - 20 Posts 3. New EC Member Category - 10 Posts

## Instructions

- Only the Life member shall be eligible to contest the election for any one post of either the Office bearer or the member of the Executive Committee and shall submit the nomination for such post duly signed, proposed and seconded by 2 (two) Life members on the nomination form to the Secretary.
- Candidates shall mention their attendance in the Annual General Body Meeting and Executive Committee Meeting as may be required for the particular post in the prescribed nomination forms failing which the nomination will be invalidated.
- The duly proposed and seconded Nomination form shall be sent to the Secretary either by Registered A/D post or by Speed post individually. 'ISP ELECTION' should be superscripted on the envelope and name of the post applied for should not be written on envelope, failing which the nomination will be invalidated.
- Nomination received after the last date shall not be accepted and rejected outright. No correspondence shall be entertained on this matter.
- Last date of receiving nomination papers – 25<sup>th</sup> July 2017.**
- Date of AGM and election – 25<sup>th</sup> November 2017.**
- The Secretary shall inform all the candidates about the acceptance/rejection of the nomination soon after the Screening and Scrutinizing committee meeting.



- h) Any candidate desirous of withdrawing the nomination may do so in writing, duly signed and addressed to the Secretary. Such withdrawal letter must reach the secretary by **5<sup>th</sup> September 2017**.
- i) The names of all the candidates whose nomination papers have been found valid and accepted will be circulated to the Life members along with the AGM notice.
- j) All eligible candidates whose nomination papers have been accepted have to be present personally at the time of election. Election of the candidate(s) in absentia shall not be permitted/allowed except under some extraordinary circumstances. However, such candidate(s) must submit the letter duly signed and addressed to the Secretary about the circumstances, as the case may be at least two days before the date of election. The Executive Committee shall consider such a written request in its due perspective and take the decision, which shall be final and binding, whether to allow such an election in absentia or otherwise.
- k) All the Life members shall bring their photo identity card at the time of election.

### **Eligibility criteria**

#### **President Elect**

Should have served in the Executive committee for five (5) terms with 50% attendance in each term, out of which, one term should have been within the preceding two years. The current year attendance should not be considered.

#### **1st & 2nd Vice Presidents, Joint Secretary, Scientific Programme Convener and Periodontal Health care Convener**

Should have served in the Executive committee for three (3) terms with 50% attendance in each term, out of which, one term should have been within the preceding two years. The current year attendance should not be considered.

#### **Executive Committee member**

Should have been a Life member of five (5) years standing and has attended at least three (3) ISP Annual General Body Meetings.

- I. **Past President Category** – Five past Presidents preceding the Immediate Past President shall be the EC members without any election or nomination.
- II. **Existing EC member Category.**
  - a) Should have been in the Executive Committee with 50% attendance in the immediate preceding year.
  - b) In case of the member, who has been in the EC for the very first term, 50% attendance in the current year till the Screening and Scrutinizing committee meeting shall be taken in to account for eligibility.
- III. **New EC member Category** - Should have been a Life member of 5 (five) years standing and has attended at least 3 (three) Annual General Body Meetings of the society.
