- F. Date of AGM and election- **12th December, 2026.**

Eligibility Criteria

OFFICE BEARERS

Should be an Executive Committee Member of the current year.

President Elect and Secretary

Should have served in the Executive committee for 5 (five) terms with at least 50% attendance in each term, out of which, 1 (one) term should have been within the preceding 2 (two) terms. The attendance of the current term should not be considered.

1st & 2nd Vice Presidents, Joint Secretary, Treasurer, Editor, Scientific Program Convener and Periodontal Health Care Convener

Should have served in the Executive committee for 3 (three) terms with at least 50% attendance in each term, out of which, 1 (one) term should have been within the preceding 2 (two) terms. The attendance of the current term should not be considered.

Executive Committee member

Should have been a Life member of 5 (five) terms and should have attended at least 3 (three) ISP Annual General Body Meetings.

1. Past President Category –

- a. 5 (Five) past Presidents preceding the Immediate Past President shall be the EC members without any election provided they have attended at least 50% of the EC Meetings in each term.
- b. They will not be eligible to fill up a nomination form for any other office bearer post till the completion of the 5 (five) term tenure.
